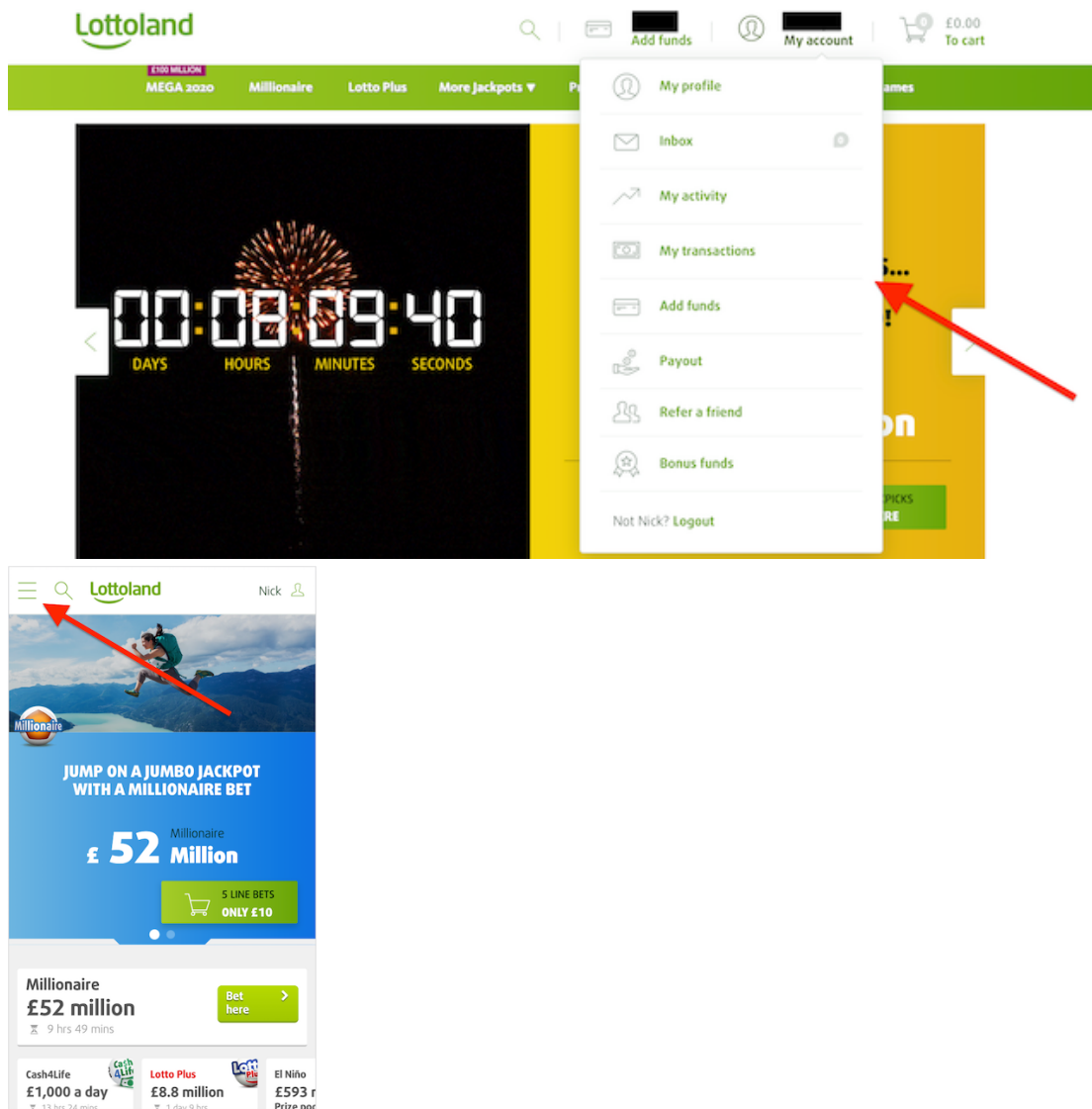

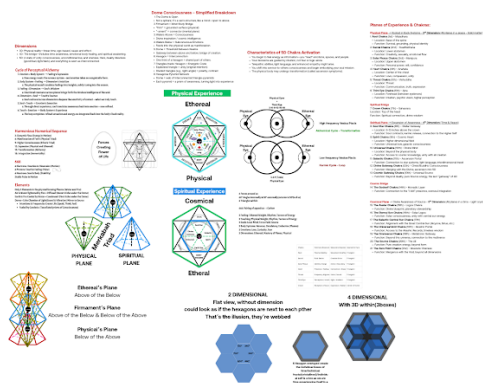

You could've chosen the red pill, but you chose the blue pill with the wrong person.

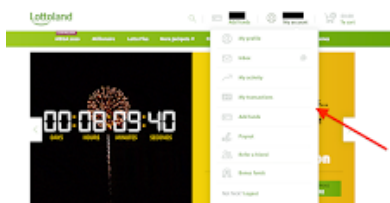
