Hi team,

Immediate Action Required — IP Use, Co-Creation Contract & Final 48-Hour Notice (Expires Tonight at Midnight)

Dear [Name / Lottoland Legal & Compliance Team],

I am writing because I have reason to believe material from my emails, blog posts and creative work — including proposals, contracts and conceptual frameworks I shared in good faith — may have been used internally by EU Lotto Ltd / Lottoland without first resolving my case or securing my consent.

You were offered a clear path to collaborate: a co-creation/consultancy contract I sent you (24-hour turnaround requested, which I extended to 48 hours). That deadline expires **tonight at midnight**. To be explicit: you have not returned a signed agreement, you have failed to update me on any changes implemented that could exonerate you from allegations of IP misuse, and you have given me zero transparency about any internal actions taken that reference my material.

I therefore require the following, immediately and no later than **midnight tonight** (local UK time):

1. A written confirmation (signed by an authorised representative) stating whether EU Lotto Ltd / any affiliate has used, adapted, implemented or otherwise relied upon any of my content, concepts, emails, contractual drafts, creative outputs, or other intellectual property (collectively “My IP”).
 - If **yes**, provide a full, itemised accounting describing what was used, when, by whom, and the commercial or operational impact of that use.
 - If **no**, provide a firm, signed statement to that effect.
2. A returned, signed copy of the **Co-Creation / Consultancy Contract** I sent (or a signed refusal explaining specific legal reasons why you decline to enter it). If you need a redline, provide it now with a named contact for immediate negotiation.
3. A list of any operational or personnel changes implemented since our correspondence that were inspired by, informed by, or materially reference my materials (names/roles can be redacted where privacy is required), together with dates those changes took effect.
4. Confirmation that you have ceased any further use of my IP pending fair commercial negotiation and/or licensing, and that no further dissemination of my materials will occur without my express written consent.
5. If you acknowledge use of my IP, a good-faith proposal for monetary remediation (licence fee or donation reflecting value gained). If you choose to treat this as a licensing matter, provide the proposed licence terms.

A reminder of context and stakes:

- I disclosed creative work, legal frameworks and commercial concepts to you in a spirit of possible collaboration and resolution.
- My IP includes my life story, artistic output, blog content, contractual drafts and conceptual models tied to my work as Founder of 4Honeth.
- I invited collaboration and gave you a realistic, limited window to respond — you were aware of the 24hr request and I extended that to 48hrs.
- I reserve all legal rights in relation to copyright, database rights, GDPR, and other applicable protections — including pursuing injunctions, damages and regulatory complaints should misuse be admitted or proven.

My exposure of your emails is in relation to your already misstep in sending unfinished documents, that was the breach that allowed me bypassing your privacy, as became reporting against conspiracy of theft, of which you could've sent completed documents, to prove the innocence, instead you allowed silence, which no matter whether there's a win or not, has caused many personal pains that could've been avoided through transparency.

This offer to negotiate in good faith remains open only until **midnight tonight**. If I do not receive the confirmations and documents requested above by that deadline, I will interpret your silence or refusal as a decision to decline collaborative resolution and I will take all appropriate next steps, which may include: immediate legal action, as I haven't sent our conversations and shortened transactions, just yet, this is all out of my own brain and AI (copyright and contract claims), escalation to regulators (GRA, ICO, UKGC and others as applicable), and public disclosure as part of my documentary and public-interest work.

If you wish to preserve the opportunity to resolve this quietly and constructively, appoint a named legal/contact person now and send the requested information and a confirmation of funds/licence proposal where applicable.
