Dear Esteemed Colleagues,

This is an updated, consolidated notice from **Susan Ndinga Wright**, Meta-Multi-Dimensional Physicist and Founder of **4Honeth**. This is **not** my last email, the resistance's intensity has risen, so will be mine. Stop looking at my creations if you're not willing to reach out like human beings do. Nosey bees don't deserve the sight. I'm not a Manga.

### What I have sent:

You have already received the **UK Authorities Class Action Proposal — Plan of Action**, which sets out practical pilots, legal architecture (the New Covenant), and an operational roadmap for embedding quantum, metaphysical and consciousness principles into UK law, education and governance. That Plan was attached and publicly referenced across my posts. Now you get what some have already seen: Empire draft and 4Honeth.

### Practical circumstances & revised timeline:

- I will **no longer** treat the original open deadline as indefinite. This is an operational update: I must **empty my storage unit by end of Tuesday**, and for practical reasons I need an acknowledgement sooner, as I have turned myself in I won't be having shelter, but a lot of time on my hands, and you've used enough time by going through my creations like peeping Toms, instead of reaching out to answer your questions, doubts, fears and hope.
- If I do **not** receive a meaningful acknowledgement by **mid-day Monday**, the current offer for cooperative engagement as set out in my Plan will be withdrawn, and if anything comes up before then, I will have to bring

that deadline even closer. If you viewed this email, you cannot have the excuse that it was Sunday. Tech tracks everything.

**Context — why I act this way:**

I made a deliberate choice to study homelessness and systemic failure from the field. I became temporarily homeless by circumstance and by design to test ideas in the lived environment and to sharpen actionable policy proposals. I am not seeking pity; I am conducting a field study and building solutions. I have long documented institutional gaps — from transactional opacity to missing legal recognition of consciousness impacts — and I have proposed pilots to fix them.

Which, if you were to preserve the silence, the silence would answer as your non-care in fixing any problems, as the only answer is to incorporate our true existence in life. Enough to have the public on my side, as I could take that as indictment content. Not put more plasters. We've done enough of that.

If I do get my own wins whether from Lottoland or the National Lottery on the 26th, I'm indicting all of you, for gross misconduct, lacking the action towards and integration of laws that save lives. I have many ways to justify every single crime since 2012 as being rooted in its absence of Meta-physics in our jurisdiction and how all you have not bettered yourselves to deliver the responsibility of your role, missing your own accountability, and for those who can be proven to have known this information, for every day went by without pushing the needle forward is a day of professional negligence. If the state is your responsibility, the least you can do is be accountable to it.

**What I ask now:**

If you wish to preserve the possibility of a cooperative, cross-sector response that pilots the changes I propose, **respond by mid-day Monday** with:

1. A short acknowledgement of receipt; and
2. A named contact (name, role, phone/WhatsApp) authorised to convene immediate follow-up.
3. Or non-engaging financial aid to proceed the projects attached below
4. Who would be your highest authority, if I was to proceed with the class action? Or you can take me to court, I'd be much happier with you taking care of the handy work and me finishing it there.

If you cannot or will not engage constructively, your silence will be recorded and I will proceed with independent and public remedies as necessary. This timeline is not personal; it is practical.

**We are opening a new timeline.** I will continue to send updates as the timeline unfolds. This is a public record of my offer, my expectations, and the actions I will take to protect the public interest and my intellectual work.

"You're not needed, you are appreciated for the opportunity given your resources.
