I received your response and, as I expected, it misses the point entirely. This isn't about reporting a crime in the conventional sense, nor is it a request that fits neatly into standard forms, boxes, or templates. The oversight here is illustrative of the very limitation I'm addressing: authority responding with procedure, rather than insight.

Your response demonstrates a systemic reluctance to engage with material that challenges conventional frameworks — material that concerns **meta-governance, human expansion, and the intersection of consciousness with structural authority**. Telling me to "submit a tip" or "contact local offices" is an attempt to reduce a multi-dimensional matter to a linear process. It's procedural safety, not accountability.

I am not here to play by procedural convenience. I am here to expose gaps, to demand reflection, and to ask those entrusted with authority to do the work for which their positions were granted. This is why I reached out: to invoke accountability in those who influence, control, and have access to resources capable of acting — not just managing forms.

The inertia of bureaucracy cannot be mistaken for compliance, and your office's response exemplifies exactly that inertia.
